2. All Comers' Track Meets	Decision was made to cancel the meets for this summer due to Covid-19. Dale will cancel the John Marshall Track reservations. Gwen made a motion to set



	up a committee to come up with an alternative for the RRC to provide some type of activity to engage youth in place of the All Comers'. Motion was seconded and all approved. Committee members will be: Dale, Brian, Anna, Branda and Cindy.
3. Website Committee	Gwen provided an update. Website is on track to go live in early May. Gwen also proposed we consider merging the HHR website with the RRC website to save expenses. Gwen will ask Aubri Robinson to prepare a proposal for the board's consideration.
Old Business	
1. RRC Club Races Updates	Many races in the community have been canceled or moved to a virtual option. Spring Classic and Rochesterfest 1 mile race have been cancelled. Summerfest is tentatively still on and monitoring the situation closely. Reggie Oetljen race is under 100 people and will determine action by end of June. Womans 4 mile race is on hold. HHR is looking at a virtual option and will make a final decision by end of June.
2. Grand Prix Status	We have received one Grand Prix sponsor donation from Final Stretch. Board members did not feel comfortable reaching out for additional sponsorships with the current uncertainty with races. Gwen will check with MDRA to see what they are doing with their Grand Prix and report at the May meeting.
3. Name Change Update	Chris Coon completed the official name change with the MN Secretary of State. Gwen completed the official name change with Think Bank. Our name is now officially Rochester Running Club.

Names of RRC board members were sent to the Park Board for consideration for involvement in the planning process. Time commitment is unknown at this time.
