Review and Approval of Financials  • 2021 Budget Update	October Financial included a \$500 deposit to the Save the Track fund from the Wine Run. CARES Act Funds helped to reduce the YTD deficit but RRC will still end the year with a deficit. Motion made to approve October Financials and board approved. 2021 RRC General Budget and 2021 RRC Event Budgets are ready for board review and approval. Board members are to review the budget spreadsheets by the Nov. Meeting. \$500 was allocated in the budget for equipment replacement.

Volunteer Recognition Program	August Drawing – Jean Murray September Drawing – Roger Heil Terra Loco gift card were provided to the drawing winners. Board members were asked to review the volunteer program document and be prepared to vote and approve at the November meeting.
RRC Collapsible Water Cup – Distribution to Membership	Pickup opportunities at Terra Loco and Running Room have been communicated to members who have not received their cup. For cups not picked up Jean Murray will deliver.
CARES Act Fund - \$1 million grant program for non-profits administered by the Rochester Area Foundation (RAF).	Grant application approved. \$4,300 check received, deposited and distributed as follows: \$3,000 reimbursement to Save the Track account for 8/1/2020 Soldiers Memorial Field Track maintenance payment. \$500 reimbursement for RRC expenses for supplies directly related to COVID including face masks, hand sanitizer, digital thermometer, and signage. \$800 in expense reimbursement for the Healthy Human Race directly impacted by COVID (medical, postage, and race timing). Required report filing on how money was distributed was submitted to RAF on 10/19/2020.
Amendment to RRC Agreement with City of Rochester – Name Change and Long Jump Pit Maintenance	Park Board approved the amendment at their study session meeting 9/15/2020. We are awaiting notice from the City Clerk regarding signatures from Dale Pfrimmer and Gwen Jacobson. Gwen has contacted Park Department several times.
